


Locate Request, Transmissions,
County ticket volume and distribution




Locate Requests for NC

December 2023 vs 2022







YTD 2023 - 2,677,733 / 2022 - 2,497,873 = +7.2 %


Updates for December 2023 – (60,202) = 32.7% of volume / November 31.5% = +1.2% (Increase the month before)

December 2023 vs 2022







The Burke / Caldwell Counties NC 811UCC monthly meeting was held on January 9, 2024, 12:00 noon at the Timberwood Restaurant in Morganton, NC. Robert Turner, Secretary called the meeting to order and offered the prayer of blessings for the meeting and meal.

A total of **10** members attended today's meeting.

1. Highlights of the NC 811 Presentation for January 2024:

- At the State UCC Meeting today in Durham.
- <u>Locates</u> for December '23 were +7.54% higher (184,086) than December.'22 (171,186). YTD Locates +7.2%.
- <u>Transmissions</u> for December '23 were +9.1% higher (998,892) than December '22 at (915,621). YTD Transmissions +6.1%.
- **Burke County:** Had a total of 825 tickets for the month, Morganton and Connelly Springs having the most.
- <u>Caldwell County:</u> Had a total of 596 tickets for the month, Granite Falls and Lenoir having the most.
- Damage Reported for December 2023: Burke County 3; Caldwell County 1; Grand Total: 848. Mechlenburg & Wake Counites has the highest number of damages.

4. Round-table Discussions:

Kevin Clark – Brentwood Water Corporation: Our new project on Snowhill Church Road has just started. Max Presswood is doing the project for Iron Mountain Works of Mountain City, TN. This project is approximately 6,000 feet of a new water line, which will tie together to separate lines. We are experiencing a lot of issues with the locators being sent out to do the NC811 locates. They are either late, or do not show up at all.

<u>Doug Suttles & Ken Suttles – Suttles Surveying Co.:</u> Still terribly busy! We too are experiencing a lot of issues with the locators being sent out to do the NC811 locates. They are either late, or do not show up at all.

<u>Jim Buckner & Rodney Roland – REMC:</u> Changing out poles and in the Cane Creek area. Have a large project off Old #10 highway running lines to the Barefoot Campground. We too are experiencing locate issues! Especially with AT & T locations.

Summary: It was the consensus of all members present at this meeting that the Locator Services currently being done in our area is not acceptable! It is keeping our companies from get the jobs done on time. And can make us liable for damages simply because the locators are not do an adequate job with underground locations of utilities.
