





February 2024 vs 2023



YTD 2024 - 453,175/2023 - 418,801 = +8.2 %


Updates for January 2024 - (68,983) = 30.44% of volume / January 32.6% = -2.16% (Decrease the month before)

February 2024 vs 2023






Transmissions YTD 2024–2,457,983 / 2023 – 2,285,679= +7.5%




