Incorrect information can lead to delays for the dig crews, damages at the excavation site, member operators not being notified.

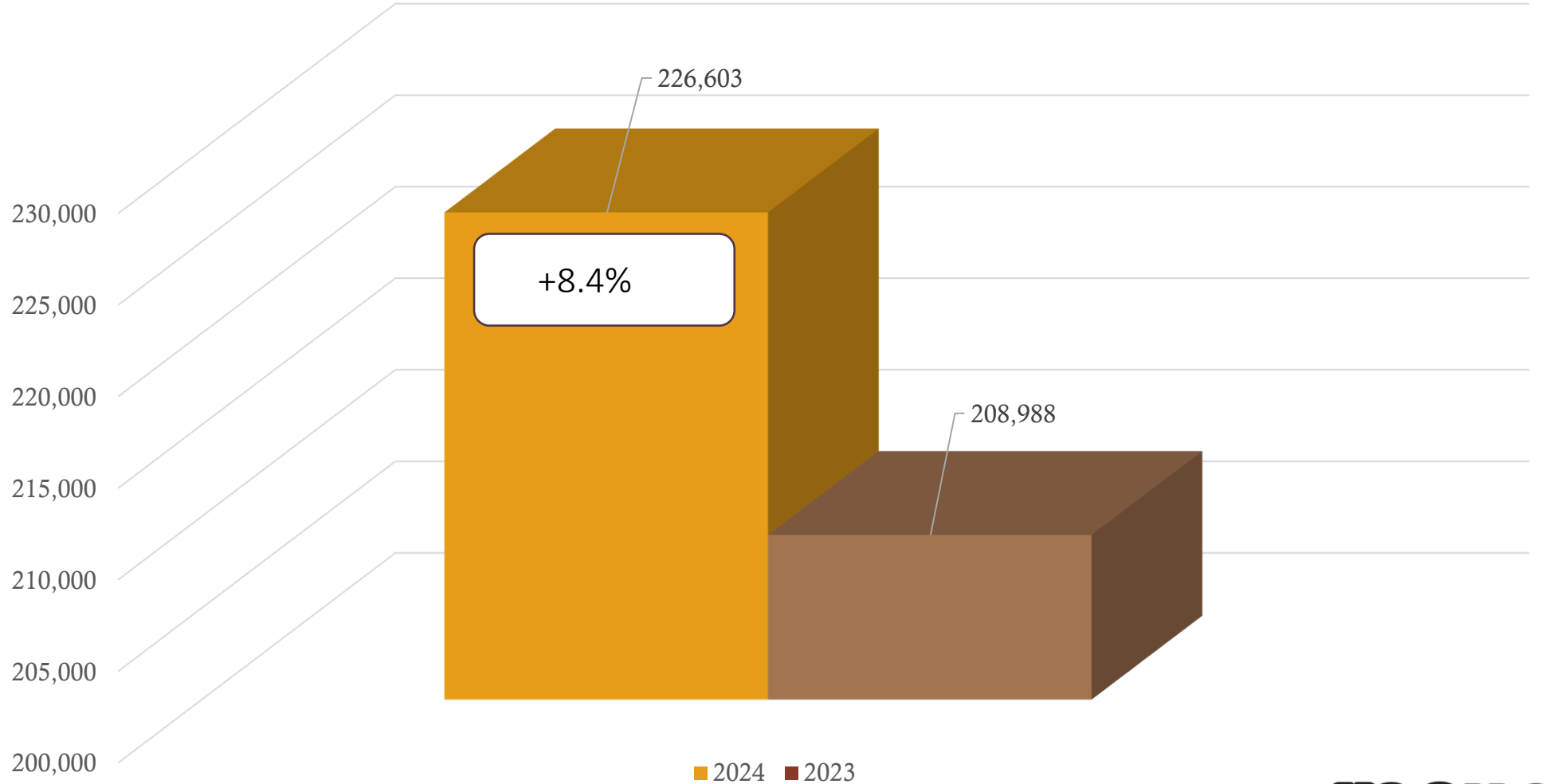
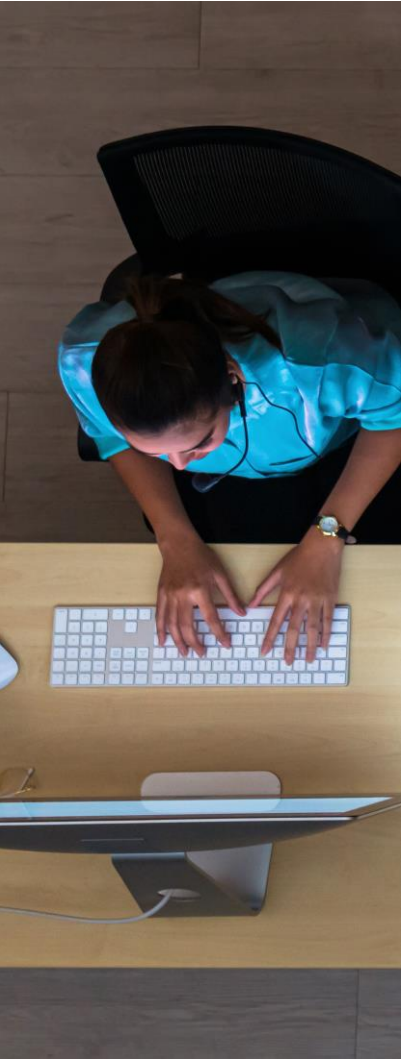

January 2024 vs 2023



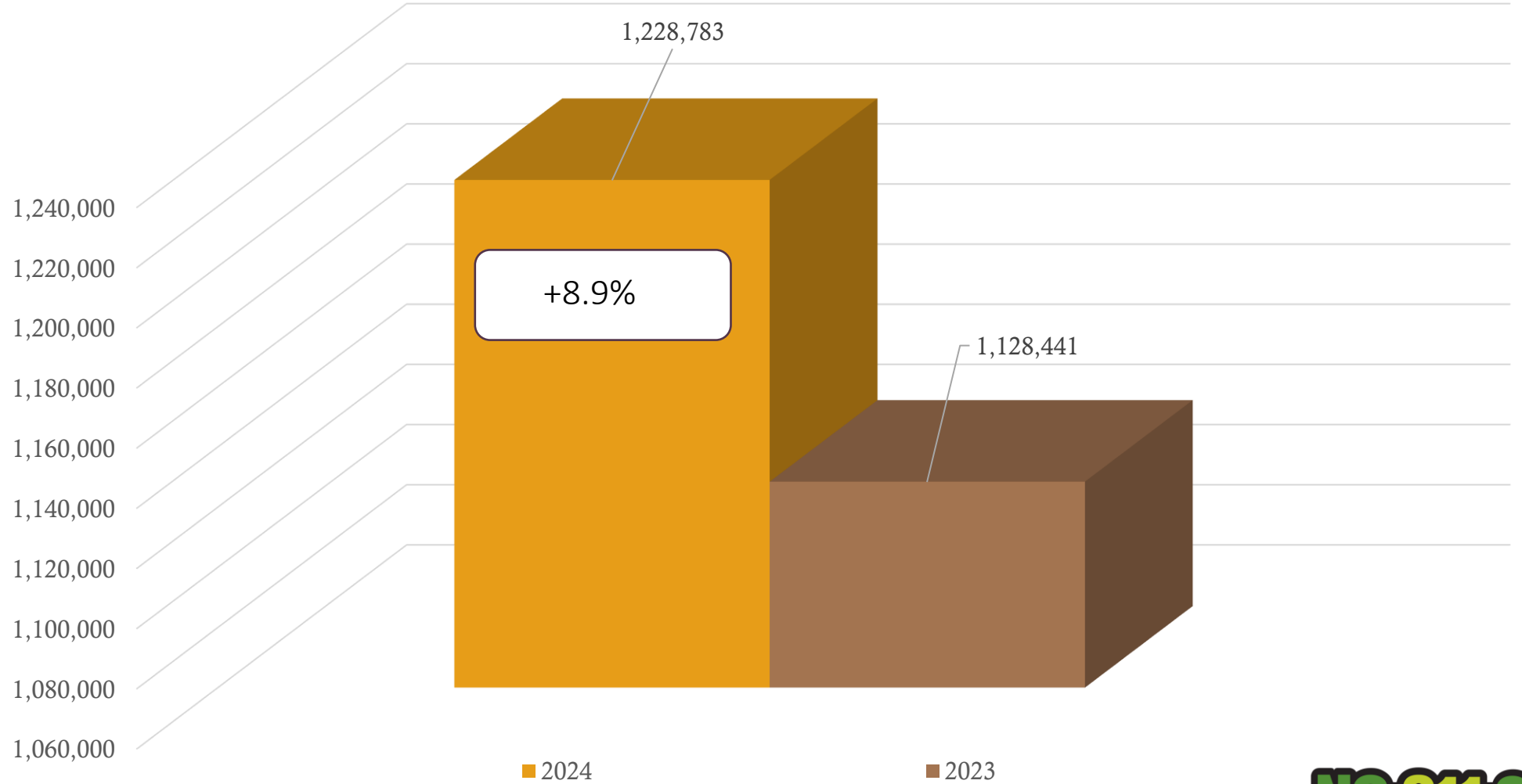
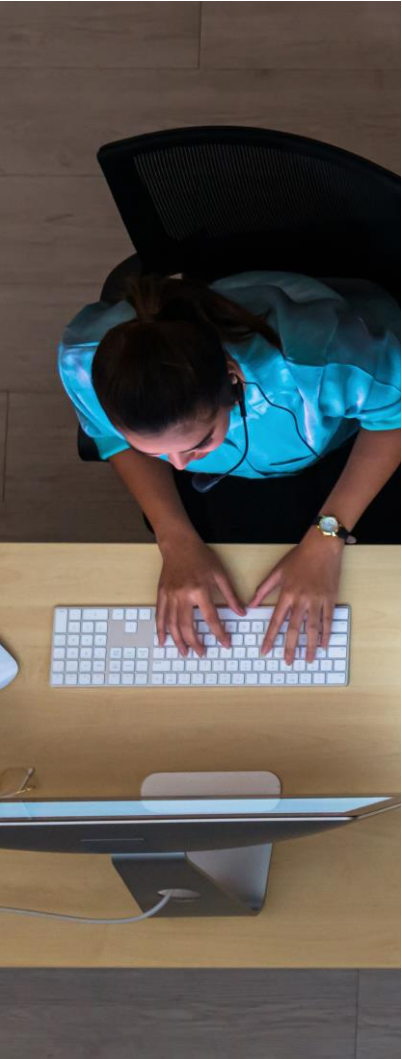
MTD January 2024 – 226,603 / 2023 – 208,988 = +8.4%

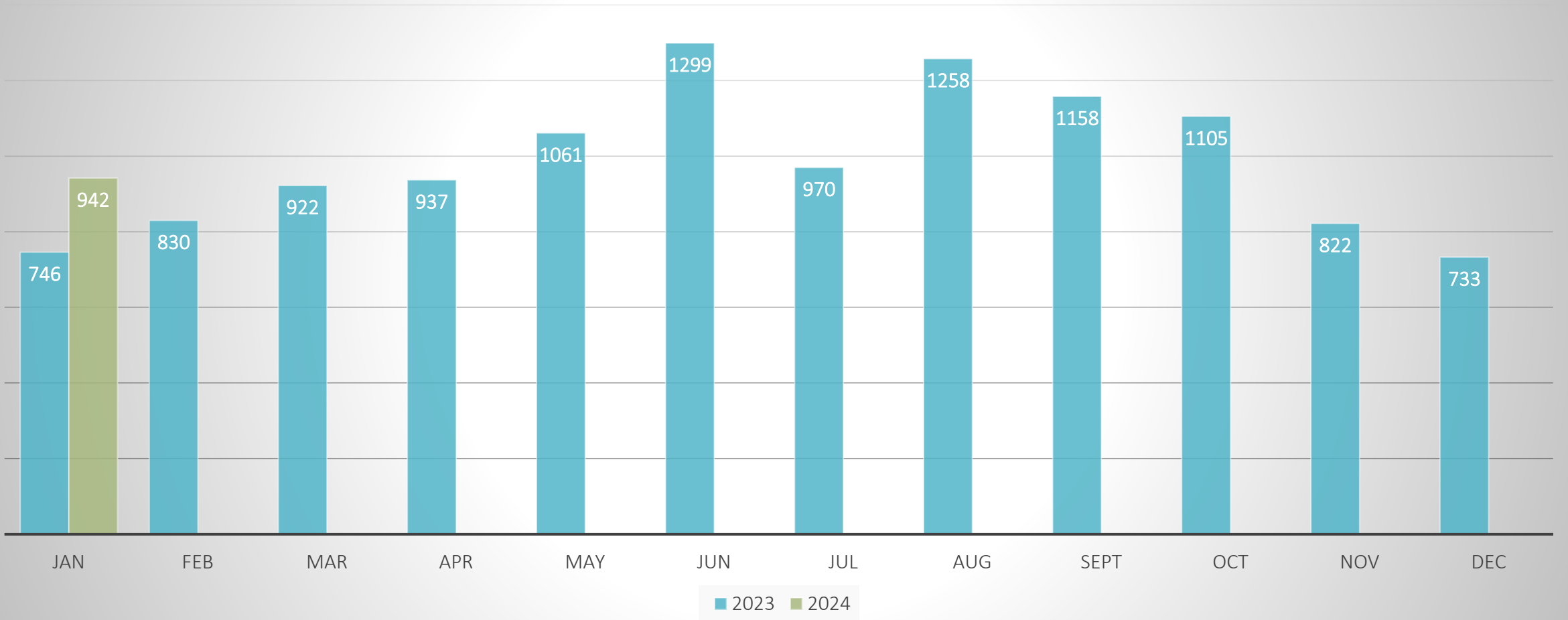
