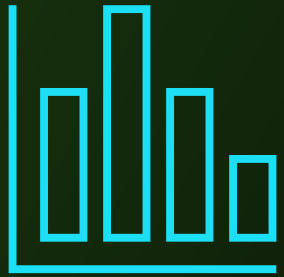

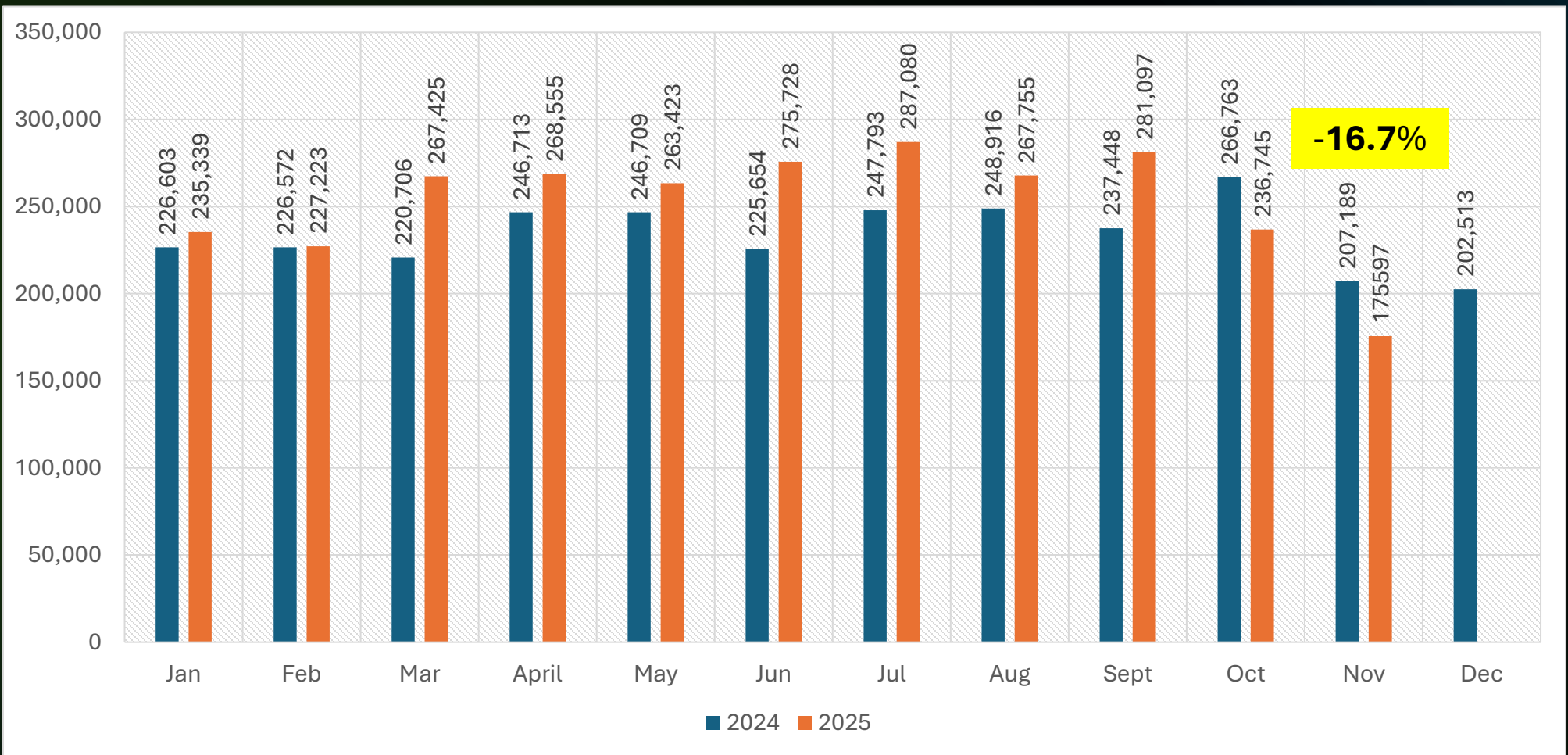

# LOCATE REQUESTS FOR NC 2024 VS 2025

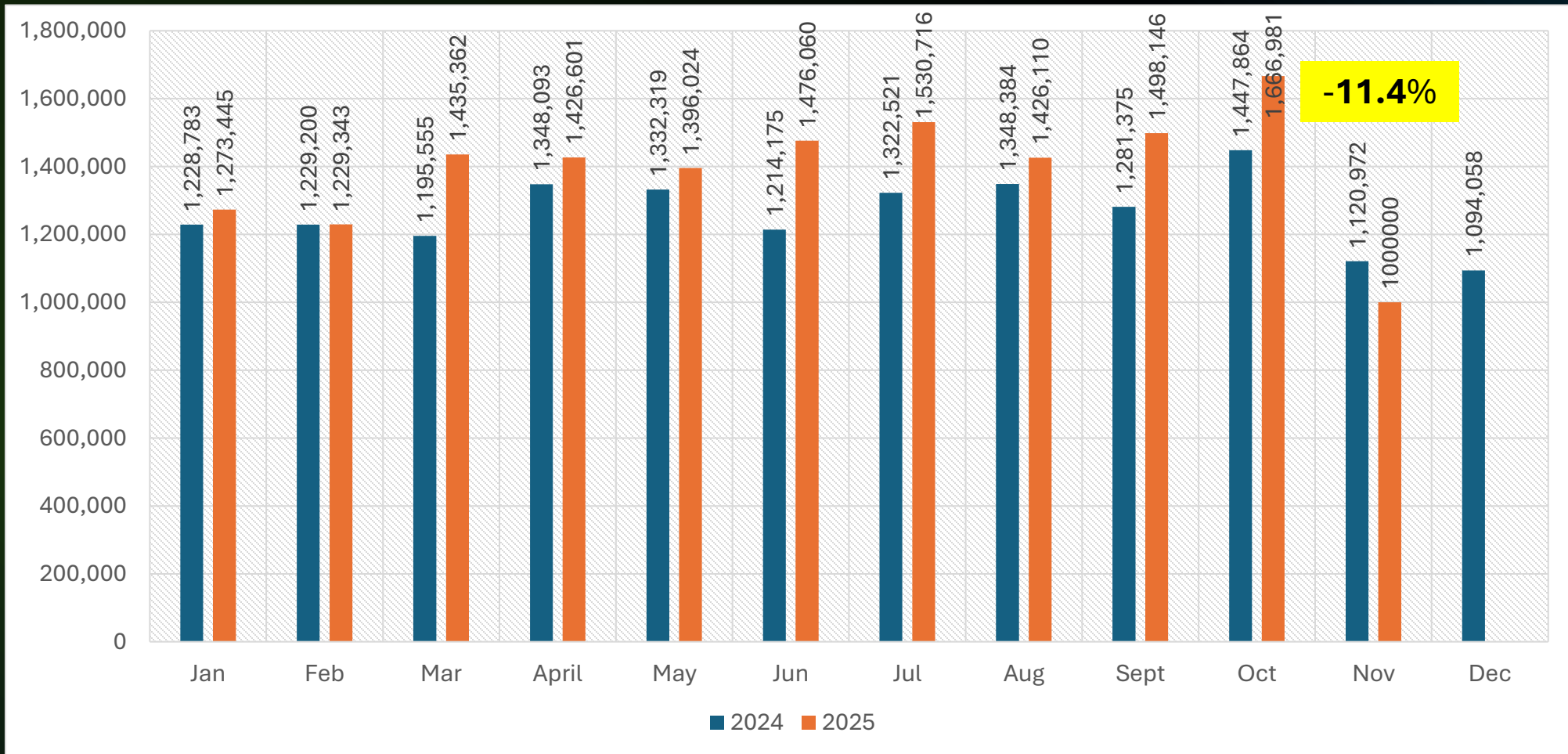
2025 YTD – 2,785,967

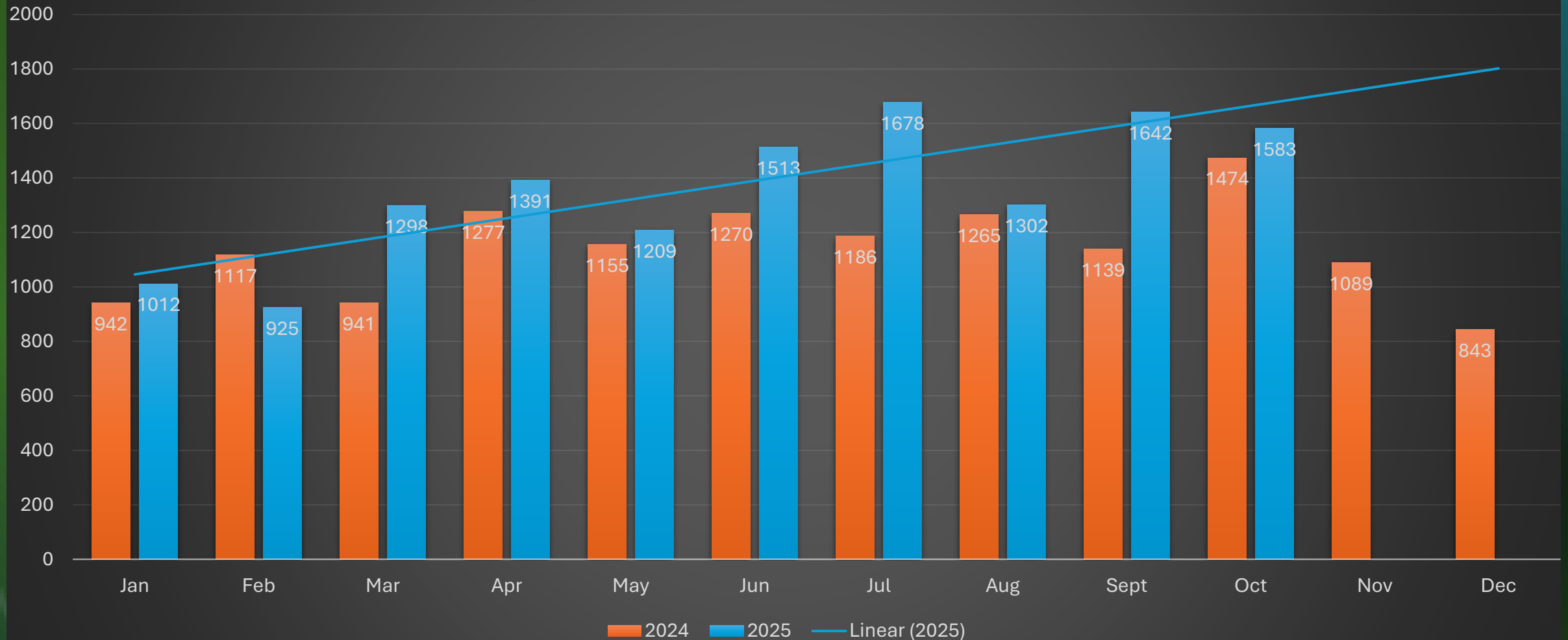

- Safety Moment Briefing Board
- NC811 Presentation Monthly Update December 2025 – Parrish Reddick
- Alamance County 12 damages – 9 excavator and 3 excavator -no cause
- Cardinal Pipeline- having issues with contractors not being mindful on NC811 tickets (transmission side) – work is being completed w/o representation being present. Tried to call and make contractor (Spectrum) aware but they will not answer calls. Suggested installing fences before work to begin.
- Cardinal Pipeline stated that contractors are working on expired tickets or working w/o any tickets. What can be done about this incident? Is anyone seeing the same issues with contractors? Cardinal is committed to helping, they are scheduled to meet w/ NCUC – scheduled on 12-8-25.
- Need to communicate with Spectrum in reference to them crossing Cardinals Pipelines.
- Enbridge will have a busy 1<sup>st</sup> quarter in the Pittsboro/Mebane areas.
- Need to get more utilities to join our UCC Bi-weekly meetings.
- Communications is still part of the issues when talking with contractors on site. Language barrier. What can be done?
- Flaggers Force – has a lot of work in the area. Currently working w/Duke on changing out poles.



- USIC – 200 tickets – only 7 late – trying to get caught up – New supervisor.
